Subject:- Grant of Yearly Permission to Shri Bhanwar Lal Dugar Ayurved Vishwabharti, Gandhi Vidya Mandir, Sardar Shahr, Dist. Churu-331403, Rajasthan, (Inst. ID-AYU0227) with 60 seats in UG (BAMS) course, under section 28 of NCISM Act, 2020 for the academic session 2025-26-reg.

Sir/Madam,

- To assess the available facilities of teaching, non-teaching, hospital staff, practical training and other infrastructure facilities at your college namely **Shri Bhanwar Lal Dugar Ayurved Vishwabharti, Gandhi Vidya Mandir, Sardar Shahr, Dist. Churu-331403, Rajasthan, (Inst. ID-AYU0227)** inspection was conducted on **17.03.2025 and 18.03.2025 in Hybrid mode** as a part of annual visitation by the visitation team of Medical Assessment and Rating Board, NCISM to process the permission with 60 seats in UG (BAMS) course under section 28 of NCISM Act, 2020.
- Further, the visitation report and all other related documents were assessed in terms of the enforced regulations namely the Minimum Essential Standards, Assessment and Rating for Undergraduate Ayurveda colleges and Attached Teaching Hospitals Regulations, 2024", provisions under the NCISM Act, 2020 and relevant Regulations there under. **On careful examination of the assessment report it is found that your college is not fulfilling the notified & approved criteria, due to the following shortcoming:**

a) Teaching staffs:-

c) Visitor observation:-

For virechan attached toilet is not present in virechana kaksha.

3. In view of above, the assessment report was placed in the **123rd Board meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) on **23.05.2025**. On careful examination of the assessment report, considering the deficiencies observed therein as mentioned above, **the Board discussed and decided to provide an opportunity of virtual hearing** vide the MARB-ISM letter (Hearing notice) of **even number** dated **31.05.2025** to appear before the designated Hearing Committee on **03.06.2025**, to present their case and to show cause as to **why not the Yearly Permission to the college with 60 seats under section 28 of NCISM Act, 2020 be denied for the Academic Year 2025-26**. The college was directed to make written submission in respect of the case and produce all relevant valid documents/records/proof to substantiate the claims against all the deficiencies/shortcomings as indicated above. The representatives of the college submitted written submissions **vide letter no.- AVB/2025/244 dated 02.06.2025** against the deficiencies conveyed to them.
4. Thereafter, the hearing was conducted on 03.06.2025 and further the observation of hearing committee based on the submission made by the college representatives during hearing and assessment report of the NCISM have been carefully re-examined in terms of Regulation according to UG Minimum Essential Standards, Assessment and Rating Regulation 2024", and provisions under the NCISM Act, 2022 and relevant regulations thereunder, and the recommendation of Hearing Committee was duly placed before the **136th Board meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) convened on 24.07.2025** and Board observed that the college is not fulfilling the notified & requisite criteria for issuance of permission as per the concerned acts and regulations but is fulfilling the criteria in accordance with the Board's policy letters issued on 09.01.2025 & 20.01.2025. Further the Board also observed that the college is not fulfilling the criteria for extended permission in accordance with regulation 54(2) of Minimum Essential Standards, Assessment and Rating for Undergraduate Ayurveda colleges 2024, as the Denial of Permission was issued to the college from the academic year 2022-23. Hence, the Board decided to issue Yearly Permission in accordance with Regulation 54(3) of Minimum Essential Standards, Assessment and Rating for Undergraduate Ayurveda colleges 2024 with an intake capacity of 60 seats in UG (BAMS) course under section 29 of NCISM Act, 2020, for the academic session 2025-26.

"DECISION"

5. Therefore, **Shri Bhanwar Lal Dugar Ayurved Vishwabharti, Gandhi Vidya Mandir, Sardar Shahr, Dist. Churu-331403, Rajasthan, (Inst. ID-AYU0227)** is hereby granted with:-

Yearly permission in UG (BAMS) course with intake capacity of 60 seats in UG (BAMS) for the academic session 2025-26 in accordance with Regulation 54(3) of Minimum Essential Standards, Assessment and Rating for Undergraduate Ayurveda colleges 2024 and;
6. The aforementioned permission is issued under section 28 of NCISM Act, 2020 subject to the condition that following requirements shall be fulfilled:-
 - I. It is informed that minimum **15% of undergraduate seats of the permitted intake capacity of 60 seats in UG Course** shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2025-26 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. **The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction for all India quota or the students admitted thereunder.**
 - II. It is also informed that determination of fee and all other charges in respect of 50% of seats in private Medical Institutions and deemed to be University should be as per the guidelines issued by NCISM vide ref no. BUSS/Fee/ASU/2022-23 dated 16.09.2022. Fees of the remaining 50% of seats are to be fixed as per the guidelines of Fee Fixation/Regulatory Committee (FRC) of respective State/UT/Deemed to be University.
7. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
8. Further, **as per Sub-section (7) of Section 29 of NCISM Act, 2020**, The Medical Assessment and Rating Board for Indian System of Medicine may conduct evaluation and assessment of any University or medical institution at any time, either directly or through any other expert, having integrity and experience in medical profession, without any prior notice and assess and evaluate the performance, standards and benchmarks of such University or medical institution and if the college is found to be not maintaining the Minimum Essential standards as specified in the concerned Acts & Regulations then **in accordance of Section 28 (1) (f) of NCISM Act, 2020 the issued permission of the college shall deemed to be withdrawn and denial of permission shall be issued by MARBISM for stoppage of admission for that particular academic year or the subsequent year.**
9. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
10. **You are hereby instructed to comply with all the requirements of Aadhaar Enabled Biometric Attendance System as mentioned in the Implementation letters vide. ref. no. 3/2024/MARB/AEBAS & HMS. Dated 09.05.2024 & 06.09.2024 issued by the Board.**
11. **The following requirements must be fulfilled and the compliance report must reach the Board by 31st December, 2025 to be considered for the issuance of permission for the academic session 2026-2027:-**
 - i) All the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled.

- ii) All the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in NCISM (Minimum essential standards, assessment and rating for undergraduate Ayurveda colleges and attached teaching hospitals) Regulations, 2024.
 - iii) All the requirements of the National Commission for Indian System of Medicine (Minimum Standards of Undergraduate Ayurveda Education) Regulations-2022.
 - iv) The compliance of shortcoming mentioned in para- 02.
12. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college within the timeline as mentioned above to the President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission for the academic session 2026-27.
